A Fireball - A Message from the President

Thank you to each and every chapter member and a special thank you to all elected and appointed officers who served in positions of chapter leadership during this year. This includes Vice-President, Tom D'Alio, Secretary Larry Powell, and Surviving Spouse Liaison Noreen Diedo. And a separate thank you to Rich Higgins who joined the chapter in January, and has served ably as Treasurer, Webmaster, and Legislative Aide.

Early in this year, the chapter conducted an in-depth chapter viability assessment and with the Michigan Council of Chapters of MOAA, developed a course of action to prepare the chapter for future success.

The chapter recruited nine additional members in 2024. Nearly 90% of chapter members have stayed with us over the last two years. The chapter held regular recruiting events in Warren and at the Selfridge Retiree Appreciation Day and encouraged each member to recruit new members.

The chapter successfully executed a comprehensive annual schedule of events with four in-person meetings and associated events. The chapter Board of Directors met on a regular basis to administer chapter operations.

We continued publishing our monthly newsletter, the Meteor; this year represented the most newsletters published in the 64-year history of the chapter. This would not have been possible without the dedicated and creative efforts of Larry Powell and Rich Higgins.

The chapter revised its MOAA online web presence and implemented its first ever website. www.semimoaa.org Again, Thank You and Well Done to Webmaster Rich Higgins for his time, skill, and initiative in providing a modern cost-effective, and informative presence on the internet.

The chapter served the community including achieving a five year high in recognizing outstanding student performance in area ROTC and JROTC programs.

The chapter volunteered and raised funds for the chapter for the first time ever.

The chapter has volunteers serving on a continuing basis in at least three different service opportunity locations. We have made inroads with MISIDE, a Detroit area social service and community support organization.

Chapter members enjoyed participation in the May International Armed Forces Night in Troy and the recent November Remembrance Service at the Cathedral of St. Paul in Detroit.

Chapter members were active in legislative advocacy on a national and state basis.

Legislative Corner

The MOAA Advocacy Update

More than 17,000 letters were sent to Congress this past summer through MOAA's Legislative Action Center to drive home the urgency of the three Advocacy in Action Summer Campaign issues. It's not too late to weigh in. It takes only a few minutes to log in to the Legislative Action Center and let your representatives hear from you.

Increasing Junior Enlisted Pay

Both the House and Senate versions of the FY 2025 National Defense Authorization Act (NDAA) include provisions addressing this issue: The House NDAA proposes a 15% pay raise for servicemembers E-1 to E-4 in addition to the 4.5% raise for all personnel, while the Senate version suggests a 1% increase for E-1 to E-3 beyond the general 4.5% raise. These measures are a step in the right direction, but continued advocacy is necessary to ensure our junior servicemembers can support themselves and their families.

Restoring the Basic Allowance for Housing (BAH)

The House version of the NDAA proposes restoring BAH to 100% for FY 2025, moving closer to our goal of a permanent fix. Unfortunately, the Senate version does not address this issue, highlighting the need for continued advocacy to achieve a comprehensive solution.

Supporting Combat-Injured Veterans

The Major Richard Star Act, which aims to eliminate the unfair offset between DoD retirement pay and VA disability compensation, has seen significant support in Congress. Despite this, neither version of the NDAA includes the bill. It remains critical that lawmakers hear from constituents on this important issue, particularly as we approach the 119th Congress.

On the state level, the Michigan Commanders Group web site includes legislative advocacy functionality that enables you to support state military legislation including initiatives for suicide prevention, hyperbaric oxygen treatment, and veteran treatment courts, among others.

Wreaths Across America, 12:00 pm, Saturday Dec 14, 2024.

This year on December 14, 2024, 4600 participating cemeteries and two million volunteers across the nation will participate in Wreaths Across America (WAA). Over nine thousand veterans are buried at Resurrection Cemetery in Clinton Township. The WAA program at Resurrection Cemetery is the second largest in Michigan.

This year's program will again include a formal ceremony followed by the wreath-laying event. WAA's yearlong mission is to Remember the fallen, Honor those that serve and Teach the next generation the value of freedom. You can sponsor one or more wreaths at this link:

Members from our Chapter will meet at the cemetery (18201 Clinton River Rd. Clinton Township, MI 48038) to attend the ceremony and participate in the wreath laying.

If this is not near your home, you can go to the web site below with the name of a cemetery to find out if they are participating. If you are coming to Resurrection Cemetery in Clinton Township, it is recommended that you arrive by 1130. Please dress appropriately considering the weather; there may be some light refreshments. Normally several hundred people attend, and the program is about an hour in duration. While you are not obligated to place a wreath, there are plenty of wreaths available. You can sponsor wreaths, but do not have to buy a wreath to place one. As of this writing, there are approximately 8,300 wreathes still needed at this location.

Awards-ROTC and JROTC Season Starting Up for MOAA Medals.

Retired Activities Office (RAO) Selfridge Air National Guard Base, Mount Clemens, MI Seeks Volunteers

The Retired Activities Office (RAO) is looking for at least two volunteers to support the office at Selfridge Air National Guard Base. Volunteers work to answer phone calls and serve clients walking into the office. Shifts are normally one day per week with three hours in the office and one hour travel time per shift. Shift days are Tuesday through Friday and shift hours are 9-12 or 12-3. The work is normally not too physical but does become more physical closer to the Retiree Appreciation Day (RAD) date. RAD support involves setting up and tear down of tables and chairs, vacuuming, and bringing food and beverages into the RAD location (Wagner Enlisted Dining Facility at Selfridge) on the base in Mount Clemens. Items of Interest

New lifetime pass available for Military Veterans and Gold Star Families to access public lands.

Starting on Veterans Day (Nov. 11), veterans of the U.S. Armed Services and Gold Star Families can obtain a free lifetime pass to more than 2,000 federal recreation sites spread out across more than 400 million acres of public lands, including national parks, wildlife refuges, and forests. Federal recreational land management agencies offer additional lifetime passes, including a Senior Pass for US citizens or permanent residents over age 62 and an Access Pass for US citizens or permanent residents with a permanent disability. More information is available on NPS.gov. The Interior Department and other federal land agencies also offer fee-free entrance days for everyone throughout the year to mark days of celebration and commemoration, including the birthday of Martin Luther King, Jr., National Public Lands Day, and Veterans Day.

Funeral Honors

The Department of Defense (DoD) is responsible for providing military funeral honors. “Honoring Those Who Served” is the title of the DoD program for providing dignified military funeral honors to Veterans who have defended our nation.

Upon the Family’s request, Public Law 106-65 requires that every eligible Veteran receive a military funeral honors ceremony, to include folding and presenting the United States burial flag and the playing of Taps. The law defines a military funeral honors detail as consisting of two or more uniformed military persons, with at least one being a member of the Veteran’s parent service of the armed forces.

The DoD program calls for funeral home directors to request military funeral honors on behalf of the Veterans’ Family.

However, the Department of Veterans Affairs (VA) National Cemetery Administration cemetery staff can also assist with arranging military funeral honors at VA national cemeteries. Veteran organizations may assist in providing military funeral honors. When military funeral honors at a national cemetery are desired, they are arranged prior to the committal service by the funeral home. The Department of Defense began the implementation plan for providing military funeral honors for eligible Veterans as enacted in Section 578 of Public Law 106-65 of the National Defense Authorization Act for fiscal year 2000 on Jan. 1, 2000.

While many cemeteries have similar eligibility requirements for burial options for Veterans and their Families, some require state residency and some services, particularly for Family members, may require a fee.

New TRICARE Contracts Take Effect Jan 1

A pair of contracts designed to improve the quality of care in Tricare’s civilian medical networks will take effect Jan. 1, 2025, according to defense officials.

The contracts are moving forward following a Jan. 31 decision in the U.S. Court of Federal Claims affirming the Defense Health Agency’s choice of TriWest Healthcare Alliance as the Tricare West Region’s new manager, denying a protest lodged by incumbent contractor Health Net Federal Services last year. The award, announced in December 2022, is worth up to \$65.1 billion over nine years. The new contracts hold the promise of greater provider network flexibility, improved choices and other benefits for Tricare beneficiaries, according to defense officials.

Humana Government Business will manage the East Region, which will cover 24 states plus Washington, D.C., and TriWest Healthcare Alliance will manage the 26-state West Region. Six states that are currently in the East Region will transfer to the West Region – Arkansas, Illinois, Louisiana, Oklahoma, Texas and Wisconsin. This shift provides a more equitable balance of beneficiaries, officials said. These states include about 1.5 million beneficiaries; all told there are about 9.6 million Tricare beneficiaries, to include members of the uniformed services, their families, retirees and their families.

TRICARE cont'd.

The new contracts, dubbed T-5 contracts, "do not change the Tricare benefit and offer all the same Tricare options," Defense Health Agency officials said in their announcement.

Enrolled beneficiaries living in either the East or West Region who don't want to change their current Tricare plan don't need to re-enroll during open season, which runs from Nov. 11 through Dec. 10.

2025 COLA: 2.5%

The September 2024 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), released Oct. 10, was 309.046, 2.6% above the FY 2024 baseline of 301.236. This means the average CPI-W for the last three months of the fiscal year (July, August, and September 2024) is 308.729. The baseline is subtracted from this figure, with the result divided by the baseline (and rounded to the nearest tenth), to determine the 2025 COLA of 2.5%: $(308.729 - 301.236) / 301.236 = 2.49\%$

Renewing Your Uniformed Services ID Card

Sponsors may request Uniformed Service ID (USID) Card renewal online, which if approved, are mailed directly to the card recipient; no in person appointments necessary. This page provides details on how to renew your USID card online.

What's Changing?

Sponsors can request card renewals online through ID Card Office Online. Cards will be printed by the Government Publishing Office and mailed to the card recipient via U.S. mail.

Requirements

- Sponsor may be a Common Access Card (CAC) holder or a DoD Self-service Logon credential holder and requesting a renewal of an active USID card.
- The Sponsor and the card recipient must have email addresses listed in the Defense Enrollment Eligibility Reporting System (DEERS) that they have authorized DoD to use for contacting them. (Authorization to use email for official contact can be made under "My Profile" on the IDCO website ID Card Office Online).
- The Sponsor's personnel status must extend at least 30 days in the future from the renewal request date.
- The card recipient has a photo saved in DEERS taken in the last 12 years.
- The card recipient's mailing address is present in DEERS and in the continental United States, Hawaii, or Alaska.
- Cannot be a Post Office (PO) Box.
